**TERMS & CONDITIONS:**

- A 50% non-refundable processing fee that is applied towards your balance will be required for all reservations.
- Any overtime will be billed in addition to original quote.
- Each trip will include a recommended 25% gratuity.
- The non-refundable balance of the remaining invoice is due 14 days prior to your scheduled event.
- No possession, sale or consumption of any type of narcotics or illegal drugs is permitted. Violations will result in immediate termination of contract and services. All money paid in advance will be forfeited and remaining balance will be charged.
- If, at the time transportation, the chartering party discloses that alcoholic beverages will be served or transported in the passenger compartment and a member of the party is under 21 years of age, a designee who is 25 years of age or older shall be present if minor is not accompanied by a parent or legal guardian. The designee shall be responsible for any foreseeable personal injury or property damage that is proximately caused by the consumption of alcoholic beverages by a person under 21 years of age. No outside alcohol is allowed at the wineries.
- Clients are responsible for his/her guests for any damage to the interior and/or equipment of the vehicle. This is including but not limited to: gum, alcohol spillage, vomiting, breakage of any glasses including decanters, breakage of lights, monitors (2), radio, DVD, and CD player. Repair and replacement of items shall have a minimum charge of at least five hundred dollars (\$500). A credit card will therefore be held on account. All passengers agree to behave in an orderly and well behaved manner. The Hopper and its partners reserve the right to expel any person from the vehicle and/or terminate the contract in the event of a violation of any of these conditions by any passenger. In the event of such early termination, no portion of the rental fees shall be refunded.
- The Hopper and its partnering transport companies shall not be held responsible for late arrival caused by (But not limited to) acts of nature, traffic delays, breakdown, incorrect pickup and drop - off information, and any situation beyond our control. In the event that any part of this contract is declared unenforceable, the remaining provisions of this agreement shall remain in full force and effect. If the vehicles rental is for a minor under the age of eighteen(18), this agreement must be signed by either a parent or legal guardian over the age of eighteen (18). All vehicles quoted are subject to availability at the time of booking. Rates are subject to change without notice.
- Winery Hopper/The Hopper partners with other transportation companies to find the best vehicle for this event. All funds paid to Winery Hopper will be used for this contracted event.
- A credit card will be kept on file in case of over time or damage fees.
